I, the undersigned, hereby acknowledge that:

1. I have read the terms and conditions at <https://bonsai-sa.co.za/docs/4x4-tour-terms-and-conditions.pdf> and the Bush Etiquette at <https://bonsai-sa.co.za/docs/4x4-tour-bush-etiquette-and-what-to-bring-along.pdf> of Bonsai Technologies (registration number 1997/010604/23), trading as Bonsai-SA 4x4 Adventures and Tours. These form part of the information and requirements of this indemnity, and I will comply with them.
2. While we will do our utmost to ensure that the tour and its associated activities are as safe, comfortable and memorable as possible, please bear in mind that they take place in remote wilderness areas. These areas involve certain increased risks, which are important to note. By signing this form, you confirm that you are aware of these risks.
3. I acknowledge that while travelling to or from the location where the tour will take place (excluded from the tour), or while travelling as part of the tour, whether on or off-road and in remote areas, and while participating in walking and hiking trails during the tour, I am aware that there are hazards and dangers associated with these and related activities (e.g. driving or being a passenger in a vehicle exposes you to normal road hazards and/or off-road hazards while driving on 4x4 trails).
4. The recovery of vehicles stuck on a 4x4 trail in sand, mud, a dry river bed, a ditch, etc. is dangerous and can result in serious injury or even death.
5. The national parks and game reserves we visit are home to a variety of wildlife, including dangerous animals such as elephants, buffalo, leopards, rhinos and lions.
6. The camps we visit may also be home to wild birds, reptiles, insects and spiders, some of which may be dangerous and/or poisonous.
7. Many of the camps and lodges we visit are not enclosed. This means that wild animals, both large and small, can wander through the camps freely, sometimes posing a danger.
8. Interacting with animals, birds, reptiles, insects or spiders is strictly prohibited, as it can be dangerous.
9. You may also be exposed to the elements, as well as criminal activity such as theft, poaching and hunting.
10. Man-made structures such as chalets, cabins, tents and hides are used during the tour. Although these structures are maintained, it is possible for them to fail and cause injury.

11. Take care when visiting areas with high cliffs, loose gravel, rocks and slippery surfaces, as these can cause serious injury.
12. I also understand that changes to the published itinerary may be necessary due to circumstances, including, but not limited to, inclement weather, flooding, fires and impassable roads. I acknowledge that, while Bonsai Technologies and its associates will endeavour to adhere to the published itinerary, they cannot be held responsible for any changes caused by circumstances beyond their control.
13. The above companies and service providers may require you to sign their own indemnities and comply with them.
14. When applicable, we made every effort to book accommodation that is suitable for guests with mobility difficulties. The accommodation is booked based on the information advertised on the service provider's website and confirmed with them by telephone or email. Guests may still encounter gravel or sand sections when moving to and from the accommodation or facilities at picnic sites.
15. I agree to follow all instructions given by the adventure, trail or field guides, camp staff or their designated assistants.
16. Medical
 - a. My general health is good and there is nothing that renders me unfit to join the tour.
 - b. I acknowledge that I am responsible for any medical conditions I may have, such as illness or allergies.
 - c. Due to the remote areas we will visit and the possible poor road and trail conditions, pregnant women are not permitted to join the tour.
 - d. I also acknowledge that I have been advised that, if the tour takes place in a malaria area in north-eastern South Africa (as indicated on the map on the website), the use of malaria prophylaxis is recommended, and that I should consult my physician.
 - e. The guide(s) are not medical professionals and are not permitted to administer medication or provide medical advice. However, they will call for emergency medical assistance when necessary, provided communication is possible. The guide(s) have a satellite phone with an emergency call option and access to the SATIB24 Crisis Call Centre. Please note that they cannot guarantee the response time of emergency services.
 - f. I will be responsible for the cost of any emergency medical assistance I receive, and Bonsai Technologies will not be liable for it.

I, my heirs, executors, administrators or assigns hereby indemnify and hold harmless Bonsai Technologies, SAN Parks, Limpopo Nature Reserves, Zambalile Hotel and Safaris, the African Ivory Route, the Kingdom of Eswatini's Big Game Parks, the Eswatini National Trust Commission and any accommodation providers or associated companies, their owners, members, directors, organisers, management, staff or helpers, from any liability or claim arising from any delay, loss, theft, inconvenience, accident, injury or death as a result of my participation in this tour, however caused.
